**Director's tickets to the All-State final concerts** - Registration for the 2010 NMEA In-service Conference/Clinic does NOT include a complimentary ticket to either All-State final concert. NMEA members **who register for the conference by November 1** will receive a personalized ticket order form. That form must be returned to the Lied Center box office and the tickets will be sent to you by mail. The tickets for pre-registered NMEA members will be offered at a discounted price of \$6.50 each. Because of the high demand for concert tickets, NMEA members will only be able to purchase two tickets to each concert during this pre-sale. Additional tickets must be purchased from the box office when the tickets are offered to the general public. To take advantage of this offer, the NMEA member must be pre-registered and must return the order form to the box office. All NMEA members not participating in this pre-sale must purchase tickets at the box office at the regular \$13.00 rate. Anyone registering at the conference will be able to purchase concert tickets at the box office, if they are still available. (All ticket orders will include an additional facility use fee.)
